

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://www.jgm-consulting.com>, and John G Mott DBA JGM-Consulting and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to John G Mott DBA JGM-Consulting include <http://www.jgm-consulting.com> and JGM-Consulting. The JGM-Consulting website is a ecommerce site. By using the JGM-Consulting website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, JGM-Consulting may collect personally identifiable information, such as your:
